Event / Travel Consent with Release from Liability

I, _____, hereby acknowledge that it is my desire for _____ to participate in church sponsored activities at St. Matthew UMC. Activities include events both on and away from church premises as well as the transportation to and from such activities.

MY CHILD IS VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES, INCLUDING ANY TRANSPORTATION REQUIRED FOR THESE ACTIVITIES. *With full knowledge of the dangers involved with these activities and travel,* I HEREBY AGREE TO ACCEPT ANY KIND OF RISKS OF INJURY AS A RESULT OF SUCH PARTICIPATION AND TRANSPORTATION.

IN CONSIDERATION FOR PERMITTING MY CHILD TO PARTICIPATE IN SUCH CHURCH SPONSORED ACTIVITIES AND FOR TRANSPORTATION TO AND FROM SUCH ACTIVITIES, I HEREBY WAIVE AND DISCHARGE ST. MATTHEW UMC AND ITS EMPLOYEES, AGENTS, AND BOARD MEMBERS FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION THAT I, OR ANY OTHER PERSON ACTING IN A REPRESENTATIVE CAPACITY ON BEHALF OF MY CHILD, MAY HAVE FOR ANY INJURY OR OTHER DAMAGES RESULTING FROM THE NEGLIGENCE OR OTHER ACTS OR OMISSIONS BY ANY EMPLOYEE, AGENT OR BOARD MEMBER OF ST. MATTHEW UMC OCCURRING BEFORE, DURING OR AFTER MY CHILD'S PARTICIPATION IN SUCH CHURCH SPONSORED ACTIVITIES OR THE TRANSPORTATION INVOLVED FOR SUCH ACTIVITIES.

I also understand that the transportation to and from these events may be in private vehicles and I hereby authorize the use of these private vehicles in the transportation of my child. THERE WILL BE NO YOUTH DRIVERS ALLOWED ON EVENTS UNLESS THEY COME IN THEIR OWN VEHICLE WITH THEIR PARENTS PERMISSION AND NO YOUTH WILL DRIVE ANOTHER YOUTH WITHOUT WRITTEN PARENT PERMISSION GIVEN DIRECTLY TO US FOR THAT SPECIFIC EVENT.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A FULL RELEASE OF LIABILITY AND AN ASSUMPTION OF RISKS AND I ACKNOWLEDGE AND SIGN IT AT MY OWN FREE WILL.
